Inactivity of twelve (12) months may cause the credit line to be suspended and/or canceled.

Should the Indiana Gaming Company, L.P. commence legal action to collect any money owed, the patron will pay the Indiana Gaming Company, L.P.'s attorney fees and the cost of collection. The Indiana Gaming Company, L.P. may, at any time, charge a service fee for any check returned unpaid. The credit limits may change at any time, with or without notice. This agreement and subsequent credit transactions shall be construed according to Indiana law; venue shall be in the courts of Dearborn County in the State of Indiana.
